GUIDELINES:

Service: Visual Sound offers a motivational sound and light system, complete with a live Disk Jockey. For a Three (3) hour occasion. Visual Sound does not charge for the set-up or take down time of equipment. The request for an extension of services beyond Three (3) hours will be granted at the mutual agreement of both visual sound and the host of the occasion for the fee of **\$50.00** per half hour. Paid in cash only at the close of the event.

Travel Charge: Visual Sound will travel any where within a 25 mile radius of Roseburg for free. If your location is further than 25 miles from Roseburg, there will be a \$1.50 per mile travel charge for every additional mile.

Deposit: The deposit will be 50% of the total contract price. This deposit is non-refundable and will be deducted from the total balance owed.

Payment: Visual Sound requires payment in full of the adjusted balance two (2) weeks prior to the occasion. No out-of-town check, please.

Down Time: If our equipment should malfunction and result in the discontinuation of your event, we will pay back \$1.00 for every minute after fifteen (15) minutes and no more than the total contract price, that our equipment is not operating, paid upon the end of your event.

Damage: Any repair costs accrued due to damage inflicted upon the sound and lighting equipment by guests, becomes the sole responsibility of the host.

Changes: Any changes to this contract without the consent of both the host and Visual Sound will declare this contract null and void. The initial 50% deposit will not be refunded, if for any reason this contract should be broken.
